To require institutions of higher education participating in Federal student aid programs to share information about title VI of the Civil Rights Act of 1964, including a link to the webpage of the Office for Civil Rights where an individual can submit a complaint regarding discrimination in violation of such title, and for other purposes.

8       On page 4, line 3, strike the semicolon at the end  
9 and insert the following: “and the number of complaints  
10 the Office has received in the previous month regarding  
11 discrimination under—

12           “(1) title IX of the Education Amendments of  
13       1972 (20 U.S.C. 1681 et seq.);

14           “(2) section 504 of the Rehabilitation Act of  
15       1973 (29 U.S.C. 794); and

16           “(3) title II of the Americans with Disabilities  
17       Act of 1990 (42 U.S.C. 12131 et seq.);”.

18       Between page 4, line 25, and line 1 of page 5, insert  
19 the following:

20           (2) the number of complaints that were sub-  
21       mitted to the institution in the previous year regard-  
22       ing discrimination in violation of—

1 (A) title IX of the Education Amendments  
2 of 1972 (20 U.S.C. 1681 et seq.);

3 (B) section 504 of the Rehabilitation Act  
4 of 1973 (29 U.S.C. 794); and

5 (C) title II of the Americans with Disabil-  
6 ities Act of 1990 (42 U.S.C. 12131 et seq.);

7 On page 5, line 9, insert paragraphs “(1) and (2)  
8 of” before “subsection (a)”.

9 On page 5, line 22, insert “and between complaints  
10 regarding discrimination in violation of title IX of the  
11 Education Amendments of 1972 (20 U.S.C. 1681 et seq.),  
12 section 504 of the Rehabilitation Act of 1973 (29 U.S.C.  
13 794), and title II of the Americans with Disabilities Act  
14 of 1990 (42 U.S.C. 12131 et seq.) that are submitted to  
15 institutions of higher education and such complaints that  
16 are submitted to the Office” after “the Office”.
