2 **SEC. ____ . ELECTRONIC PRIOR AUTHORIZATION FOR PRE-**
3 **SCRIPTION DRUGS.**

4 (a) PHSA.—Part D of title XXVII of the Public
5 Health Service Act (42 U.S.C. 300gg–111 et seq.) is
6 amended by adding at the end the following:

7 **“SEC. 2799A–11. ELECTRONIC PRIOR AUTHORIZATION FOR**
8 **PRESCRIPTION DRUGS.**

9 “(a) IN GENERAL.—For plan years beginning on or
10 after January 1, 2027, a group health plan or health in-
11 surance issuer offering group or individual health insur-

1 ance coverage shall provide for the secure electronic trans-
2 mission of—

3 “(1) a prior authorization request from the pre-
4 scribing health care professional for coverage of a
5 prescription drug for a participant, beneficiary, or
6 enrollee in such plan or coverage to such plan or
7 issuer; and

8 “(2) a response, in accordance with this section,
9 from such plan or issuer to such professional.

10 “(b) ELECTRONIC TRANSMISSION.—

11 “(1) EXCLUSIONS.—For purposes of this sec-
12 tion, a facsimile, a proprietary payer portal that
13 does not meet standards specified by the Secretary,
14 or an electronic form shall not be treated as an elec-
15 tronic transmission described in subsection (a).

16 “(2) STANDARDS.—In order to be treated, for
17 purposes of this section, as an electronic trans-
18 mission described in subsection (a), such trans-
19 mission shall comply with technical standards adopt-
20 ed by the Secretary, in consultation with the Sec-
21 retary of Labor, the Secretary of the Treasury, the
22 National Council for Prescription Drug Programs,
23 other standard-setting organizations as determined
24 appropriate by the Secretary, and stakeholders, in-
25 cluding group health plans and health insurance

1 issuers offering group or individual health insurance
2 coverage, health care professionals, and health infor-
3 mation technology software vendors.

4 “(3) APPLICATION.—Notwithstanding any other
5 provision of law, for purposes of this section, the
6 Secretary may require the use of standards adopted
7 under paragraph (2) in lieu of any other applicable
8 standards for an electronic transmission described in
9 subsection (a) for prescription drugs for a partici-
10 pant, beneficiary, or enrollee described in such sub-
11 section.”.

12 (b) ERISA.—

13 (1) IN GENERAL.—Subpart B of part 7 of sub-
14 title B of title I of the Employee Retirement Income
15 Security Act of 1974 (29 U.S.C. 1185 et seq.) is
16 amended by adding at the end the following:

17 **“SEC. 726. ELECTRONIC PRIOR AUTHORIZATION FOR PRE-**
18 **SCRIPTION DRUGS.**

19 “(a) IN GENERAL.—For plan years beginning on or
20 after January 1, 2027, a group health plan or health in-
21 surance issuer offering group health insurance coverage
22 shall provide for the secure electronic transmission of—

23 “(1) a prior authorization request from the pre-
24 scribing health care professional for coverage of a

1 prescription drug for a participant or beneficiary in
2 such plan or coverage to such plan or issuer; and

3 “(2) a response, in accordance with this section,
4 from such plan or issuer to such professional.

5 “(b) ELECTRONIC TRANSMISSION.—

6 “(1) EXCLUSIONS.—For purposes of this sec-
7 tion, a facsimile, a proprietary payer portal that
8 does not meet standards specified by the Secretary,
9 or an electronic form shall not be treated as an elec-
10 tronic transmission described in subsection (a).

11 “(2) STANDARDS.—In order to be treated, for

24 “(3) APPLICATION.—Notwithstanding any other
25 provision of law, for purposes of this section, the

1 Secretary may require the use of standards adopted
2 under paragraph (2) in lieu of any other applicable
3 standards for an electronic transmission described in
4 subsection (a) for prescription drugs for a partici-
5 pant or beneficiary described in such subsection.”.

6 (2) CLERICAL AMENDMENT.—The table of con-
7 tents in section 1 of the Employee Retirement In-
8 come Security Act of 1974 (29 U.S.C. 1001 et seq.)
9 is amended by inserting after the item relating to
10 section 725 the following:

“Sec. 726. Electronic prior authorization for prescription drugs.”.

11 (c) IRC.—

12 (1) IN GENERAL.—Subchapter B of chapter
13 100 of the Internal Revenue Code of 1986 is amend-
14 ed by adding at the end the following:

15 **“SEC. 9826. ELECTRONIC PRIOR AUTHORIZATION FOR PRE-**
16 **SCRIPTION DRUGS.**

17 “(a) IN GENERAL.—For plan years beginning on or
18 after January 1, 2027, a group health plan shall provide
19 for the secure electronic transmission of—

20 “(1) a prior authorization request from the pre-
21 scribing health care professional for coverage of a
22 prescription drug for a participant or beneficiary in
23 such plan to such plan; and

24 “(2) a response, in accordance with this section,
25 from such plan to such professional.

1 “(b) ELECTRONIC TRANSMISSION.—

2 “(1) EXCLUSIONS.—For purposes of this sec-
3 tion, a facsimile, a proprietary payer portal that
4 does not meet standards specified by the Secretary,
5 or an electronic form shall not be treated as an elec-
6 tronic transmission described in subsection (a).

19 “(3) APPLICATION.—Notwithstanding any other

22 under paragraph (2) in lieu of any other applicable
23 standards for an electronic transmission described in
24 subsection (a) for prescription drugs for a partici-
25 pant or beneficiary described in such subsection.”.

2 tions for subchapter B of chapter 100 of the Inter-
3 nal Revenue Code of 1986 is amended by adding at
4 the end the following new item:

“Sec. 9826. Electronic prior authorization for prescription drugs.”.
