ALTERNATIVE MINIMUM.—If the sum ap-

1	propriated under the authority of section
2	214 and not reserved under subsection (a)
3	for any fiscal year exceeds the aggregate of
4	the allotments for all States under this
5	subsection for fiscal year 2019, yet is in-
6	sufficient to fully satisfy the requirement
7	of clause (i), such excess amount shall first
8	be allotted among the States described in
9	clause (i)(I) so as to increase equally the
10	minimum allotment for each such State
11	above \$680,000. After the requirement of
12	clause (i)(I) is fully satisfied for any fiscal
13	year, any remainder of such excess amount
14	shall be allotted among the States de-
15	scribed in clause (i)(II) so as to increase
16	equally the minimum allotment for each
17	such State above \$60,000.".
