9 on May 26, 2016, including the contemporary
10 examples of Anti-Semitism cited by the Alli-
11 ance.

12 “(B) ENTITY.—The term ‘entity’ means a
13 public elementary school or secondary school
14 (including a charter school), local educational
15 agency, State educational agency, postsecondary
16 program, or institution of higher education.”.

17 On page 181, line 11, strike “years.” and insert
18 “years. No funds provided under this section may be pro-
19 vided to an entity that ^{promotes} allows Anti-Semitism to occur on
20 the campus of such entity or served by such entity in viola-
21 tion of title VI of the Civil Rights Act of 1964 (42 U.S.C.
22 2000d et seq.). In this section, the terms ‘Anti-Semitism’
23 and ‘entity’ have the meanings given the term in section
24 182(e).”.

1 On page 188, after line 25, add the following:

2 **SEC. 306. RESTRICTION.**

3 Section 305 (20 U.S.C. 9624) is amended by adding
4 at the end the following:

5 “(c) RESTRICTION.—

6 “(1) IN GENERAL.—No funds provided under
